## 1. Introduction

#### 1.1 The focus of the evaluation

## 3. Progress made on previously-identified improvement targets

#### Literacy and numeracy

Our previously identified target was that our standardised test results in Drumcondra tests would be equal to or better than the national norms during the 10 year period.

## 4. Summary of school self-evaluation findings

## **4.1** Our school has **strengths** in the following areas:

- Attainment in standardised tests of Literacy and numeracy has improved over recent years and is
  equal to or above the national norms.
- Participation of pupils in the process and performance of drama is at a high level and pupils report high levels of satisfaction.

## **4.2** The following areas are prioritised for improvement:

- Literacy. The school is currently introducing a comprehension programme called "Building bridges of Understanding".
- Literacy. Oral language to be developed further.
- Mathematics. Effective, accurate and consistent use of mathematical language among pupils is to be prioritised.
